

2019-2020 ENROLLMENT AGREEMENT CENTRAL FLORIDA CHRISTIAN ACADEMY

This is an Agreement for the entire 2019-2020 school year by and between Central Florida Christian Academy (the "School"), and me/us, the undersigned parent(s), legal guardian(s), and the party(ies) financially responsible for the student(s) named in this Agreement.

TERMS AND CONDITIONS:

In consideration of the School's acceptance of this enrollment agreement, I/we agree to accept and support the policies of the School and to pay, when due, the required charges for tuition and fees as indicated herein. By signing this Agreement, I/we acknowledge that I/we are requesting that the School and desire for the School to make yearlong financial commitments to teachers, administrators, vendors and others on our behalf and on behalf of our student. I/we further acknowledge and understand that the School may not be able to decrease, change or cancel the obligations it makes to others on our behalf if we fail to pay the tuition and fees required for the full year covered by this Agreement. **Therefore, EXCEPT AS PERMITTED IN PARAGRAPH 9 BELOW, I/WE AGREE TO PAY THE FULL YEAR'S TUITION AND FEES, WHETHER OR NOT OUR STUDENT ATTENDS THE SCHOOL FOR THE FULL YEAR.** I/We further understand that this Agreement is for the full school year, not just for a portion of the year (e.g. month to month), even though I/we may choose to pay my/our obligation for the full year in more than one payment as a convenience to me/us.

1. I/We have carefully examined the Statement of Doctrinal Beliefs, philosophy and Christian purpose of Central Florida Christian Academy, and desire that Central Florida Christian Academy, in cooperation with me/us, seek to provide our student with a total spiritual and academic program of education.
2. For the 2019-2020 school year, CFCA will use **FACTS Management of Lincoln, NE** to collect monthly tuition payments. Therefore, unless I/we pay in full in advance, or make a special arrangement with the School's Finance Office, I/we agree to make all tuition payments by automatic debit from my/our checking/savings account on the 5th or the 20th of each month. The first payment is due by June 1, 2019 for annual payment or by June 5th or June 20th for equal monthly payments. If a payment is missed, a \$ 25.00 missed payment fee will be assessed for each missed payment attempt. A \$25.00 fee will also be collected for each returned debit or check. If I/we choose not to sign up with FACTS management or I/we make a single tuition payment in the CFCA administrative offices I/we understand I/we will be charged a \$25.00 fee per transaction.
3. I/We give consent for CFCA and FACTS to use automatic telephone dialing systems and an artificial or pre-recorded voice to provide updated information regarding your agreement. This would include calls made to the phone numbers listed on your account, including wireless numbers.
4. I/We understand and agree that grades, administration of exams, testing results, cumulative records, transcripts and any information generated by or submitted to the School by me/us or others for my/our student become the property of the School and will not be released to student or family or any other party until the account is paid in full. The School may require cash, cashier's check, or money order as payment at its discretion. At the School's discretion, the full amount of the remaining unpaid tuition, fees, and any other charges may become due and payable if the account is delinquent for sixty (60) days. I/we understand and agree that if the account becomes 60 days delinquent, the School, at its discretion, may suspend student's attendance at School or terminate this agreement with respect to any or all students described herein and apply the termination charges as noted in section 9. I/we further understand and agree that if my/our account is or becomes delinquent, the School may seek collection thereof through a 3rd party collection agency and such delinquency may be reported to consumer credit agencies.
5. The administrators of the School and the teachers, coaches, and other staff serving under them shall have full discretion in the administering of appropriate discipline of the student. The School reserves the right to adopt and/or alter rules and regulations from time to time, and all students enrolled shall comply fully with the rules and regulations then in force as stated or amended. I/We understand that it is required that all parents/guardians be familiar with the Parent-Student Handbook as published and updated on the School's website and abide by the terms, provisions, obligations, and requirements thereof and as amended from time to time. My/our signatures on this Agreement mean that we have read, understand and agree with the provisions in the Parent-Student Handbook.
6. I/We understand that any campus property or personal property destroyed, damaged or lost by our student(s) will be replaced or repaired immediately, and the cost therefor shall be borne by the undersigned.
7. I/We understand and agree to obtain, at the School's discretion and request, substance abuse testing for our student and will cover all costs associated with such testing, and to complete the test within a 24-hour window of the request being made by the school.

8. The School believes that a positive and constructive working relationship between Central Florida Christian Academy and each Student's parent/guardian is essential to the accomplishment of the School's educational mission. Accordingly, the School reserves the right to terminate or not renew the Student's Enrollment Agreement if the School reasonably concludes that actions of a parent/guardian make such a positive and constructive relationship unlikely or otherwise seriously interfere with the School's accomplishment of its educational purposes.
9. I/We agree to cooperate with School administration in seeing that the student regularly attends classes on time and has transportation from the School premises at the close of the school day; in assisting the student to learn and advance in the educational process; in solving school-related problems; and in aiding the teachers in providing the student with a Christian education. I/We understand and agree that the School reserves the right to terminate or not renew the Student's Enrollment Agreement if the School reasonably believes that it cannot serve the needs of the Student.
10. I/We understand that I/we are responsible for and **obligated to pay the full non discounted tuition and fees for our student(s) for 2019-2020 as follows:**
 - a. Between February 28, 2019 and June 1, 2019 I/we may cancel this Agreement without further obligation and receive a full refund of tuition paid, except that the School will retain and/or be entitled to collect the Enrollment Deposit and all fees.
 - b. Between June 2, 2019 and before or on July 15, 2019, I/we may cancel this Agreement without further obligation and receive a refund of tuition paid except that the School will retain and/or be entitled to collect the Enrollment Deposit, all fees and 5% of the tuition due under this Agreement.
 - c. After July 15, 2019, if a student covered by this Agreement withdraws or is dismissed from the School before the school year is completed, the School will retain and/or be entitled to collect the Enrollment Deposit, all fees and all tuition paid for any quarter (9-week grading period) completed or then underway, plus 10% of the prorated tuition for any quarter not yet underway. A quarter or grading period is considered to be underway on the first day of that quarter.
 - d. The School is not obligated to issue a refund of excess tuition until my/our written request for a refund is received by the School. The School will issue such refund within 15 school days of approving such a request.
 - e. Any funds owed to the School for this student or any other student with the same financially responsible party for unpaid balances of any kind, unreturned or damaged School property, unpaid damages to facilities, balances from prior years or any other charges incurred by or on behalf of this student by the School, its staff, First Baptist Church Central Florida, or vendors representing the School will be deducted from the proceeds of any refund. The School may, at its sole discretion, apply any refund due hereunder toward the payment of any other balance(s) for any other student(s) from the same family or same financially responsible party.
11. Need-based Tuition Assistance may be available. Families must complete a Tuition Assistance application and submit it to the outside financial assessment agency. Information is available from the Admissions Office beginning with re-enrollment. Grants are awarded on the basis of financial need as determined by the School's Financial Assistance Committee. Application does not guarantee the receipt of a grant. Processing of application takes approximately 4-6 weeks. Tuition payments for financial assistance applicants will begin in June regardless of grant application status. If tuition assistance is applied for within 10 business days from paying enrollment deposit, this Agreement may be cancelled, in writing, within 10 business days after receiving notice of a grant award if the financial assistance is deemed to be inadequate. As provided in the paragraph above, any need based assistance or other discounts are forfeited in their entirety in the event this agreement is terminated by either party. Tuition Assistance awards are subject to the student remaining in good standing financially, behaviorally, and academically.
12. I/We understand the importance of keeping the School up to date regarding certain issues that affect our student and the School. Therefore, I/we will notify CFCA of changes in residences, employment, phone numbers, emergency contacts, and email by immediately updating my/our information at the family's RenWeb site. In addition, I/we will immediately and in person deliver to the principal or headmaster any medical information or court orders involving my/our student that may affect the School and/or its staff and their ability to provide proper safety and care for my/our student.
13. This Agreement shall not be valid until such time as the School has reviewed its contents and notified the student and/or Parent/Guardian in writing of such acceptance.

Student/Parent/Guardian Photography Consent

I/We and on behalf of the student(s) hereby authorize the School, First Baptist Church of Central Florida, and their legal representatives and assigns, the irrevocable and unrestricted right to use and publish video or photographs of me/us or the student to which I/we am/are the parent(s) or legal guardian(s), which may be included in any editorial, trade, advertising or other medium at the sole discretion of Central Florida Christian Academy without restrictions. I/We and the student understand that publication may be accomplished electronically via the Internet, and that after publication, Central Florida Christian Academy will not be able to prevent persons from gaining access to the Internet, copying my/their photographs and video, and subsequently using, altering, or republishing it without my/our consent. I/We and on behalf of the student hereby release Central Florida Christian Academy from any and all liability, claims, causes of action, arising out of, or created by, the use of my/our and the student's video/photographs relating to said video/photographs. This Consent and Waiver will continue in full force and effect until terminated in writing by the parents/guardians to Central Florida Christian Academy; provided, however, such termination shall be effective only for such videos and photographs taken after the receipt of such written termination.

Student Internet Usage Guidelines

Student(s) understands that Internet access is for School related use and not for leisure activities such as personal shopping and/or playing games. Student agrees that he/she will uphold the moral and ethical standards of the School by accessing only wholesome sites. Student understands that his/her use of the Internet is logged and may be reviewed by others. Student acknowledges that misuse of Internet access could result in dismissal from the School. The undersigned has discussed these usage guidelines with the student.

Mediation and Arbitration Agreement

This Enrollment Agreement is subject to arbitration pursuant to Chapter 682 of the Florida Statutes, known as the Florida Arbitration Code. The parties to this agreement are Christians and believe that the Bible commands them to make every effort to live at peace and to resolve disputes with each other in private and within the Christian community in conformity with the biblical injunctions of 1 Corinthians 6:1-8, Matthew 5:23-34, and Matthew 18:15-20. Therefore, the parties agree that they will attempt to resolve any claim or dispute arising out of, or related to, this agreement or to any aspect of the student-school/church or parent-school/church relationship, including statutory claims, through biblically-based mediation conducted by a mediator selected by and agreed upon by the parties.

Following the same biblical injunctions, the parties further agree that, if resolution of the dispute and reconciliation does not result from mediation, the dispute shall then be submitted to a single independent and objective arbitrator for binding arbitration. The parties shall jointly select the arbitrator. If the parties are unable to reach an agreement as to the selection of the arbitrator, the parties shall select an arbitrator through the following process:

Each of the parties shall present a list of five potential arbitrators who have had previous experience as arbitrators. If the parties' lists contain one or more names that are the same, then the parties shall strike all other names from the lists. If there are more than two names that are the same, each of the parties will strike a name. If there are then more than two names remaining each party shall strike another name. This procedure shall continue until there is only one or two names remaining. If there is one remaining name on the list, that person shall serve as the arbitrator. If there are two names remaining after the striking process, then the final person shall be chosen by lot and serve as arbitrator.

Any arbitration shall be conducted as provided in the Florida Arbitration Code as limited by the provisions of this Agreement. Specifically, a party may not file a motion with the arbitrator to seek a change to the award under Section 682.10 of the Florida Arbitration Code except upon the grounds that are set out in Section 682.13 of the Florida Arbitration Code for vacating an award. The arbitrator shall specifically include in any modified award made as a result of a motion under Section 682.10 an award of fees and costs incurred by the prevailing party in preparing for and arguing the motion, against the party who did not prevail upon the motion.

In connection with any arbitration, each party may be represented by counsel and have the opportunity to present proof through testimony and documentary evidence and to cross-examine witnesses. Prior to any arbitration, the parties shall, at a minimum: (a) exchange relevant documents, (b) identify witnesses, and (c) conduct no more than one deposition for each side. Other discovery will be available only at the arbitrator's discretion. The hearing shall be conducted in Orlando, Florida. The arbitrator shall allow the submission of dispositive motions and shall decide same. The arbitrator shall submit to the parties a signed written statement reflecting the Arbitrator's decision as to each claim and a concise written statement of the reasons for the decision. The arbitrator shall decide the merits of any claim based upon the evidence presented (whether in the arbitration hearing or in sworn declarations submitted in connection with a dispositive motion) and the applicable Florida or federal laws.

The parties agree that these methods shall be the sole remedy for any controversy or claim arising out of this agreement or any aspect of the student-school/church or parent-school/church relationship, and expressly waive their right to file a lawsuit against one another in any civil court for such disputes, except to enforce a legally binding arbitration decision.

Signature and Completion of Enrollment Agreement

The *Statement of Doctrinal Beliefs*, the *Parents/Guardian Statement of Support* and the *Student Code of Conduct and Agreement* are attached and made a part of this agreement.

STATEMENT OF DOCTRINAL BELIEFS

An individual or organization's choices and behavior arise from what they believe and value. Understanding what CFCA believes and values is important because it helps families comprehend the underlying reasons for school policies and decisions. Not all of CFCA's family members will embrace all of these beliefs as their own. However, by signing this Enrollment Agreement and attending school at CFCA parents (and students who are old enough to comprehend these beliefs) are recognizing and accepting this statement as the guiding principles for CFCA and affirming that they will adhere to these doctrinal beliefs. If a parent or student would find it difficult to adhere to any part of this Statement, they should make the Headmaster aware of their concerns and discuss them with him before signing this Agreement and beginning to attend school at CFCA.

THE SCRIPTURE: We believe the Bible to be the verbally inspired Word of God; the only infallible, authoritative Word of God. It is our supreme and final authority for faith and practice (II Tim. 3:15-17).

GOD: We believe in one God, eternally existing in three persons: Father, Son, and Holy Spirit (Gen. 1:1; Deut. 6:4; John 4:24; Rom. 8:14-15).

JESUS CHRIST: We believe in the deity of our Lord Jesus Christ, His virgin birth, His sinless life, His miracles, His substitutionary and atoning death, His bodily resurrection, His ascension to the right hand of the Father, and His future personal return in power and glory (Isa. 7:14; John 1:1-18).

HOLY SPIRIT: We believe that the Holy Spirit is the third person of the Trinity, one with the Father and the Son, the indweller of every believer, whereby each is sealed unto the day of redemption of the Body. His presence in the Christian is the assurance of God to bring the believer into the fullness of the stature of Christ. We believe that the "Fullness of the Holy Spirit" is evidenced by the fruit of the Spirit (Gal. 5:22-23) and by power in witnessing (Acts 1:8; John 15:1-8).

SATAN: We believe in the existence and operating power of a real and personal being the evil one called Satan, or Devil, opposed to all righteousness and exalting himself against all that God is and desires (I Pet. 5:8-9).

HELL: We believe in a literal Hell, the place of eternal punishment for those who have not trusted in the shed blood of Jesus Christ as atonement for their sin. (Luke 16:19-31; Matt. 25:46, II Thess. 1:9).

HEAVEN: We believe in the literal place called Heaven where God's immediate presence is manifested, where the angels are, and where the redeemed shall ultimately be, from whence Christ descended and ascended again, where He makes intercession for the saints, and from whence He shall come to judge the quick and the dead (Heb. 12:22-23; John 3:5; II Pet. 1:10-11).

MAN: We believe that God created man in His own image, and in a state of innocence, but that after temptation, man willfully sinned. All mankind is born dead in trespasses and sins and under condemnation, having inherited a corrupt nature (Psa. 51; Rom. 1; Eph. 2:1).

SIN: We believe that Adam, the first man, sinned by disobedience. This act resulted in the fall of all mankind; therefore, all people have sinned and lost their ability to live for the glory of God. Every person's sin incurs both physical and spiritual death until there is forgiveness and salvation by the grace of God. (Genesis 3:1-24; Romans 3:10-23, 5:12-21, 6:23)

SALVATION: We believe that the Lord Jesus Christ died for our sins according to the Scripture, as a representative and substitutionary Sacrifice; that He arose from the dead in His glorified body, ascended into heaven, and that, as our great High Priest and Advocate, He ever lives to make intercession for us. All who believe on His name are justified on the basis of grace through faith in Him. The believer is therefore eternally secure, kept by the power of God (Acts 16:30-31; Eph. 1:2-10, Rom. 5:8-10; John 3:16-18; I Peter 1:5).

REGENERATION: We believe that regeneration is a divine and instantaneous work of the Holy Spirit whereby God imparts life to one dead in trespasses and sin when he trusts Christ as personal Savior. (II Cor. 5:17-20; John 3; Gal. 2:20; 5:22-25).

SANCTIFICATION: We believe that sanctification is a divine and progressive work of the Holy Spirit whereby God, upon the ground of the finished work of Christ on the cross, His present intercessory ministry and His Divine Word, sets the believer apart and works out, in and through him, by means of a submissive will that which is well-pleasing to Himself, through Jesus Christ. This work culminates in the redemption of the body (Phil. 2:12-13; Eph. 5).

THE CHURCH: We believe in the one true Church, the mystical Body and Bride of the Lord Jesus, composed of believers from Pentecost to the Rapture, into which believers are baptized by the Holy Spirit. We believe that the local church is an organization composed of professing believers instituted for the purpose of fellowship, worship, and service. In matters of administration and policy, it is self-governing (Matt. 16:15-19; Acts 2:41-42; Eph. 1:22-23; I Tim. 3:1-15).

BAPTISM: We believe that Christian baptism by immersion of a believer in water in the name of the Father, Son, and Holy Spirit, is the Bible mode of baptism and testifies of the believer's faith in and identification with the crucified, buried, and risen Savior (Matt. 3:13-17; 28:19-20; Rom. 6:3-5).

THE LORD'S SUPPER: We believe that the Lord's Supper is an ordinance whereby believers "show forth the Lord's death until He comes" back for them (I Cor. 11).

THE SECOND COMING OF CHRIST FOR HIS CHURCH: We believe in the glorious hope of the premillennial, visible, and bodily return of Christ (I Thess. 4:13-18; John 14).

SEPARATION: We believe that every child of God should demonstrate his separation unto God and the world system. This separation involves a fruitful, spirit-filled life of obedience to the commands of scripture and the refusal to associate with, or become involved in anything that would bring reproach upon the character and work of Christ and His church (11 Cor. 6:14-18; Eph. 1; Rom. 12:1-2).

SALVATION: We believe the salvation of lost and sinful people is a free gift of God's grace apart from human works, based solely upon Christ's vicarious and atoning death, effected by the regenerating work of the Holy Spirit, and received only through faith in the person and finished work of Jesus Christ on the cross and His resurrection from death. (Ephesians 2:8-10; 2 Corinthians 5:21)

THE CHURCH: We believe that the church is the body of Christ and the family of God. It is made up of saved and baptized believers, who regularly join together for worship, fellowship, and ministry. (Matthew 16:18; 1 Corinthians 12:12-14; Hebrews 10:25)

10. I/We understand that the School reserves the right to dismiss the student when either the parents/guardians or the student does not cooperate with the policies of the School.
11. I/We will volunteer for duties and responsibilities for Central Florida Christian Academy as opportunities arise and God provides the time and strength.
12. I/We will be faithful to attend all parent functions at Central Florida Christian Academy as best we can.
13. If I/we become dissatisfied with Central Florida Christian Academy in any way, I/we will strive to resolve the matter with the person(s) involved as privately and lovingly as possible, rather than spreading criticism and negativism. (Matthew 18:15-17; 5:23-24)
14. I/We will seek to support and advance Central Florida Christian Academy in every area possible – spiritually, academically, physically, and financially.

As the parents/guardians of the student, I/we covenant to support the School in its efforts at Christian education. I/We agree that it is my/our responsibility to strive diligently toward the observance of the “Parent/Guardian Statement of Support” as God enables me/us by the power of the Holy Spirit. If for some reason I/we become dissatisfied, I/we promise to handle the matter as privately and lovingly as possible. If support or resolution cannot be reached, I/we recognize it is my/our responsibility to leave the School and seek a school in alignment with our personal convictions.

As it is imperative that the School know the backgrounds of parents who volunteer to work with our students, I/we understand and agree that the School shall have the right to request a background review or check on me/us at any time and the right to request a motor vehicle records review if I/we am/are required to transport students. I/we further understand that refusal to submit to such checks, or adverse findings in such checks, may limit my/our ability to volunteer at the school.

STUDENT CODE OF CONDUCT AND AGREEMENT

CFCA desires that every student reflect a lifestyle pleasing to Jesus Christ both at and away from the School. Because of this, who the student is and what the student does at all times, both on and off campus, are extremely important. Since the testimony of our lives is so important, I/we and the student(s) have read and agree to the following section which pertains to student's conduct both on and off campus, during and after school and at all times and places.

No student or adult can live life from two differing sets of standards and values. The choices one makes give evidence of the values one holds. The School requires that students sign the Student Code of Conduct and Agreement when entering the Middle School, indicating that they understand and will honor these standards on and off campus, upholding CFCA's highest commitment to Biblical principles. Character and moral absolutes do not stop when students are dismissed at the end of the school day. Twenty-four hours a day, seven days a week, everyone is challenged to honor Christ. The School has been, and always will be, concerned about the behavior of students both on and off campus. In no way does the School want to usurp the parental authority or create a legalistic atmosphere; the School wants to unapologetically advance Biblical standards, moral absolutes, and a personal commitment to our Savior and Lord. The School wants students to internalize these Biblical principles.

1. The student agrees to strive for excellence as a student in all that he/she says and does.
2. The student agrees to obey the Bible in speech and conduct.
3. The student agrees to respect and cooperate with those in authority at the School.
4. The student agrees to abstain from alcohol, illegal and/or unprescribed drugs and tobacco in any form.
5. The student agrees to abstain from cursing, sexual immorality (which includes sexual contact between unmarried individuals), dissension, stealing, lying, and cheating.
6. The student agrees to the dress code that has been set by the School.
7. The student agrees to submit to the discipline policies of the School.
8. The student understands that once he/she enrolls at the School, he/she is a part of the School family wherever he/she is. Therefore, the student agrees to abstain from behavior, both on and off campus, which violates school policies and/or which would dishonor Jesus Christ, the School, the church, his/her family, and himself/herself.
9. The student understands that the School can hold him/her accountable for any negative behavior, both on and off campus, at any time during the year.

If the parents/guardians and student do not agree and cannot support these standards, then CFCA may not be the right choice as a school. Of course, the School realizes that there will be differences of opinion on certain issues of minor import, but the School expects and desires parent and student support. CFCA is grateful to partner with families to advance an educational training center based on Biblical principles.
