**NON-REFUNDABLE Enrollment Deposit (\$350):** This deposit is part of the tuition and, when paid, will be deducted from the total tuition. It is due upon enrollment (or re-enrollment) for each student. This deposit is Non-Refundable and ensures a space at Central Florida Christian Academy in the appropriate grade for a student until June 1, 2021, when tuition payments (annual or monthly) become due. If tuition payments are not made as scheduled the deposit may be forfeited and the student’s place in school may be awarded to another student at the school’s discretion.

Curriculum Fees

**All fees for 2021-2022 school year will be billed after March 1, 2021 for re-enrolling students and are due by June 1, 2021, except as indicated below. Fees will be billed at the time of enrollment for new students and are due by August 1, 2021 or upon enrollment, if after August 1, 2021.**

**Curriculum Fee** – Provides for classroom materials and classroom activities throughout the school year. All items purchased become property of CFCA and are non-refundable.

*\*Includes the additional costs for baccalaureate and graduation expenses and other materials, activities and functions specifically planned for seniors.*

**Monthly Payment Service Charge (\$50 per family):**

This fee of \$50 per family covers the cost of setting up and processing tuition accounts when parents select a monthly payment schedule with FACTS Management. This fee is not assessed for accounts which are paid in full by June 1, 2021. After June 1, 2021 all accounts that have not already been paid in full will be assessed this fee, whether or not full payment is subsequently made. Any payments made in CFCA administrative offices are assessed a \$25.00 fee per transaction.

**McKay Grant Processing Fee (\$395):** For students enrolling in CFCA with a McKay grant. This fee offsets a portion of the added cost CFCA incurs for providing assessment, classroom accommodations, record keeping and other expenses on behalf of the student.

**Other Charges/Fees:** Mission trips, extended grade or class trips, college tours, service projects, retreats and other special functions and events that are not included in tuition may require additional fees. These activities are generally elective in nature, and the school will sometimes provide avenues of fundraising for students to earn a portion of these costs.

**Payment of Tuition and Fees:** Payment of the Enrollment Deposit is due at time of enrollment or re-enrollment. A student will not be considered enrolled until this deposit is paid. Parents or guardians may choose to pay the tuition in full at the time of enrollment or in 10 or 12 monthly payments beginning June 1, 2021. Any funds received by the school under this Enrollment Agreement for any purpose whatsoever may, at the school's discretion, be retained by the school and applied toward any unpaid balances owed to the school for current or prior year's obligations and charges.

## Extended Day Fees

### Hours:

Monday, Tuesday, Thursday, and Friday 3:00pm to 6:00pm

Wednesday 2:30pm to 6:00pm

### Full Day Program:

Cost: \$1,800.00 per year.

The full day program covers extended day for all school days.

### 3 Day Program:

Cost: \$1,100.00 per year.

The 3 day per week program covers any three days per week. If your child attends more than 3 days per week the fourth and fifth days are charged at the drop in rate.

### 2 Day Program:

Cost: \$750.00 per year.

The 2 day per week program covers any two days per week. If your child attends more than 2 days per week the third, fourth, and fifth days are charged at the drop in rate.

### Drop in Program:

Cost: \$20.00 per day.

If your child is not registered in one of the above programs and your child attends extended day either pre-arranged or they were sent because of late pick up from car line you will be charged \$20 per day. This fee is incurred 10 minutes after normal start time.

### Late Pick Up Fee:

Cost: \$1.00 per minute

If your child is picked up after 6:00pm from extended day each minute late you will be charged \$1.00.



## Tuition Discount Opportunities

---

**Church Member Discount Program** – This discount is provided primarily to assist members of Church at the Cross who have a financial need. It is the desire of CFCA to work closely with church members of CATC to have CFCA as their child's school.

- A 10% discount from base tuition will be applied per child attending CFCA.

To be eligible for this discount, BOTH of the following must apply:\*

At least one parent in a student's family must be a member in good standing of Church at the Cross for at least 90 days prior to requesting the discount.

At least one parent is enrolled and actively attending an adult Life Group class.

**\*Families who request the Church Member Discount are stating that they are complying with these expectations.**

**\*Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts. Discounts will be adjusted accordingly.**

If a student who has received this discount withdraws or is dismissed before the end of the school year or such student(s) parent ceases to be an FBCCF member, the amount of this discount will be reversed and immediately become due and payable.

**Kingdom Family Training Discount** – This \$250 discount is an annual discount available to all families for completing two of the following Kingdom Family Training opportunities within the academic year:

1. Financial Peace University – Offered each semester (8 sessions). (Where applicable both parents must attend)
2. Parenting/Family Workshop – Offered between June 1, 2021-May 31, 2022. This conference should be at least 4 hours in length. (Where applicable both parents must attend)
3. Church Training/Connection Classes – Offered between June 1, 2021– May 31, 2022. This training class should be at least 8 hours in length and support Kingdom Education principles. (Where applicable both parents must attend)
4. Marriage Conference – Offered between June 1, 2021-May 31, 2022. This conference should be at least 4 hours in length and both parents must attend.
5. Volunteer hours – A minimum of 10 hours completed between June 1, 2021 – March 31, 2022. Service hours must be completed in the same school year as the discount applies. To qualify, such hours must be completed by the legal guardian(s), regardless of whether the custodial parent is the financially responsible party.

\* The discount will be applied at the completion of the second item above.

\* If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

**\* Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts. Discounts will be adjusted accordingly.**

**Student Referral Discount** – A \$250 discount will be applied to the tuition of any family that has referred a new student to CFCA and the new student is accepted, enrolled, and completes the academic year. The referred student must complete the application process, admissions interview process, be working on grade level, be behaviorally mission appropriate, and supportive of the school's Biblical Worldview. This discount will be applied once a new student has completed the academic year at CFCA. Student Referral Discount can only be claimed by one CFCA family and cannot be split among families. If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

**\*Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts. Discounts will be adjusted accordingly.**

**Full Payment Discount** –Tuition accounts which are paid in full by June 1, 2021 will receive a tuition discount of \$200. In addition, full payment waives the \$50 Monthly Payment Service Fee. Annual payments must be received by June 1, 2021 for returning students or at the time of enrollment for new students to qualify for this discount. If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

**\*Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts. Discounts will be adjusted accordingly.**

**Early Reenrollment Discount** – Early reenrollment discounts vary upon the time the student reenrolls to CFCA. A currently enrolled family's tuition account for all children must be paid up to date in order to receive this discount for the 2021-2022 school year. If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

A discount of \$500 will be applied for students who are reenrolled with enrollment deposits paid or postmarked by March 31st, 2021.

**\*Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts. Discounts will be adjusted accordingly.**

**Alumni Discount** –A 5% discount is offered if the student(s) legal guardian graduated from or attended PHCA/CFCA for a minimum of 4 years and left in good standing. If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

**\*Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts. Discounts will be adjusted accordingly.**

**Legacy Discount** — Per student not family, the fifth consecutive year of reenrollment with CFCA, that student will receive \$100 per year for each year reenrolled. This excludes grades K5 to 4th. Students reenrolling into grades K5 to 4th will receive \$100 per year for each year reenrolled. This discount is contingent upon your account remaining in good standing for the school year. If at any point your account reaching 60 day past due this discount will be revoked, in its entirety for the school year.

**\*Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts. Discounts will be adjusted accordingly.**

**Active Military/First Responders**— A 10% discount is offered if the student(s) legal guardian is actively serving in the military or currently employed as a first responder. A 5% discount is offered if the student(s) legal guardian is a retired military or first responder. If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

**\*Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts. Discounts will be adjusted accordingly.**
