



# **DISCOUNT OPPORTUNITIES**

## **2025-2026**

**1.) Church Member Discount Program:** This 10% discount is provided primarily to assist members of Church at the Cross (CATC) who have a financial need. It is the desire of CFCA to work closely with church members of CATC to have CFCA as their child's school. A 10% discount from base tuition will be applied per child attending CFCA.

To be eligible, BOTH of the following must apply:

- At least one parent in a student's family must be a member in good standing of CATC for at least 90 days prior to requesting the discount.
- At least one parent is enrolled and actively attending an adult Life Group class.

\*Families who request the Church Member Discount are stating that they are complying with these expectations.

\*If a student who has received this discount withdraws or is dismissed before the end of the school year or such student(s) parent ceases to be a church member, the amount of this discount will be reversed and immediately become due and payable.

**2.) Kingdom Family Training Discount:** This \$250 or \$500 discount is an annual discount available to all families for completing Kingdom Family Training opportunities within the academic year. Attendance is required to receive discount.

- Kingdom Parenting Nights - Offered between August 1, 2025 - May 31, 2026. The workshops will be offered during the Fall and Spring Semester. Attendance is required to receive the full discount. When applicable, both parents must attend.

\*The discount will be applied at the completion of each semester.

\*If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

\*Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts.

**3.) Full Payment Discount (Non-State Scholarship Students Only):** Tuition accounts which are paid in full by July 1, 2025 receive a tuition discount of \$500. Annual payments must be received by July 1, 2025 for returning students or at the time of enrollment for new students to qualify for this discount. If a student who is awarded this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

**4.) Early Re-enrollment Discount:** Early reenrollment discounts vary upon the time the student re-enrolls to CFCA. A currently enrolled family's tuition account for all children must be paid up to date in order to receive this discount for the school year. If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable. A discount of \$500 will be applied for students who are re-enrolled with enrollment deposits paid or postmarked by February 28th, 2025. A discount of \$250 will be applied for students who are re-enrolled with enrollment deposits paid or postmarked between March 1st and March 31st, 2025.

\*Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts.

**5.) Alumni Discount:** A 5% discount is offered if the student(s) legal guardian graduated from or attended PHCA/CFCA for a minimum of 4 years and left in good standing. If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

**6.) Student Referral Discount:** A \$250 discount will be applied to the tuition of any family that has referred a new student to CFCA and the new student is accepted, enrolled, and completes the academic year. The referred student must complete the application process, admissions interview process, be working on grade level, be behaviorally mission appropriate, and supportive of the school's Biblical Worldview. This discount will be applied once a new student has completed the academic year at CFCA. The Student Referral Discount can only be claimed by one CFCA family and cannot be split.

**7.) Legacy Discount:** Per student not family, the fifth consecutive year of reenrollment with CFCA, that student will receive \$100 per year for each year re-enrolled. This excludes grades KS to 4th. Students re-enrolling into grades KS to 4th will receive \$100 per year for each year re-enrolled when they enroll for fifth grade. This discount is contingent upon your account remaining in good standing for the school year. If at any point your account reaches 60 days past due this discount will be revoked in its entirety for the school year.

**8.) Hero Discount (Active Military/First Responders):** A 10% discount is offered if the student(s) legal guardian is actively serving in the military or currently employed as a first responder. A 5% discount is offered if the student(s) legal guardian is a retired military or first responder. If a student who has received this discount withdraws or is dismissed before the end of the school year, the amount of this discount will be reversed and immediately become due and payable.

- \* Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts.
- \* This is a physical document that requires signatures and to be notarized before being submitted.
- \* It is required that this document is updated yearly in order to qualify for discount.

**9.) Pastoral Staff/Ministry Staff:** A 10% discount is offered if the student(s) legal guardian is a full-time, current, pastor or employee of a like-minded church or para-church ministry.

- \* Families receiving scholarship monies cannot receive a discount to exceed a zero balance on accounts.
- \* It is required that this document is updated yearly in order to qualify for discount.
- \* This is a physical document to be approved by our administration.
