Family Empowerment for Educational Options (FES-EO), Florida Tax Credit (FTC), or Academic Achievement Accessible (AAA)

- MUST BE APPLIED FOR IMMEDIATELY (limited funds available)
- Available to any student entering KS through 12th grade
- Scholarship must be renewed every school year
- New Applications for the school year will begin in early 2025.
- This is a first come, first serve scholarship. APPLY EARLY!

The Family Empowerment Scholarship for Students with Unique Abilities (FES-UA)

- Available to any Florida public school student with an Individual Education Plan (IEP) or 504 Plan from public school
- Once accepted into CFCA, the McKay/FES-UA Scholarship continues until the student graduates from high school

CFCA Needs Based Financial Aid (FACT S Grant and Aid)

Tuition assistance will only be offered to CFCA students who have completed the enrollment or re-enrollment process and paid the enrollment deposit for the school year in which they are applying for tuition assistance. Assistance is limited and awarded on a first come first serve basis.

WHAT YOU WILL NEED:

- Payment of the \$30.00 nonrefundable application fee. (If you do not pay online it does delay the process)
- Copies of your most recent IRS Federal Form 1040, 1040A or 1040-EZ U.S. Individual Income Tax Return.
(If applicant and co-applicant file separately, you will need both tax returns for the same tax year.)
- Copies of all previous year W-2 Wage and Tax Statements for both the applicant and co-applicant.
NOTE: Please submit Wage and Tax Statements as soon as they become available.
- Copies of all supporting tax schedules if you have income from any of the following:
 - Business - (Form 1040 Line 12) Schedule C or C-EZ and Form 4562 Depreciation and Amortization
 - Farm - (Form 1040 Line 18) Schedule F and Form 4562 Depreciation and Amortization
 - Rental Property- (Form 1040 Line 17) Schedule E (page 1)
 - S-Corporation - (Form 1040 Line 17) Schedule E (page 2), Form 1120S (4 pages), Schedule K-1 and Form 8825
 - Partnership - (Form 1040 Line 17) Schedule E (page 2), Form 1065 (5 pages), Schedule K-1 and Form 8825
 - Estates and Trusts - (Form 1040 Line 17) Schedule E (page 2), Form 1041 and Schedule K-1

IMPORTANT: If you file a tax return but do not have W-2 wages because you are self-employed, you will be required to submit a copy of your previous year Federal Form 1040 Tax Return.

- Copies of all supporting documentation for household Non-Taxable Income such as: Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and Temporary Assistance for Needy Families (TANF).

You are responsible to pay the remaining balance of your tuition after any scholarship or financial aid is applied.
