

#### PRIORITY STANDARDS FOR ADMITTANCE TO CFCA

- 1. Families with church membership at the Church at the Cross (CATC).
- 2. Families with siblings currently enrolled in good standing.
- 3. Families with a pastor recommendation from evangelical church
- 4. Participation in Open House event or engagement in a scheduled tour of CFCA.

#### **GENERAL ADMISSIONS CRITERIA**

- Applicants will be considered for enrollment on a student-by-student basis according to the following criteria as applicable by
  grade (please note that meeting the minimum criteria is not a guarantee of admission. Other factors such as space in the grade,
  the number of qualified applicants, siblings of current students are also considered.
- The parent and student are in support of CFCA mission as a Christian school.
- Report Cards must show minimum grade of B or equivalent for incoming 1<sup>st</sup> 5<sup>th</sup> graders and a C+ minimum for 6<sup>th</sup> 12<sup>th</sup> graders.
- Students in good standing at their previous school as provided by the Behavior Reports (most recent two years and present).
- Students with an IEP, or 504 (within the last three years) must meet the admission requirements and understand admission may not be offered if it is determined that CFCA is unable to meet the academic, emotional, medical, or behavioral needs of the student. Failure to report or withhold this information will result in the invalidation of the application.
- The student must read, write and speak fluent English.
- For students entering Kindergarten, the student must be age five (5) by September 1st of the school year.

### FIRST YEAR SENIOR (AT CFCA) ADMISSIONS CRITERIA/ QUALIFICATIONS/ POLICY:

CFCA takes seriously its mission and understands that a partnership grows through time. Therefore, the following enrollment requirements are set to assure the best possibility for CFCA to positively impact a new student and family spiritually and educationally.

#### Character

- 1. At least two letters of recommendation submitted.
  - Preferably one from their current minister/pastor and one from their most recent school.

## Academic

- 2. Graduation credits must be on schedule. No summer school or FLVS will be accepted in order to bring credits up to date.
- 3. Student must have an unweighted 2.5 GPA.
- 4. Student records (transcripts) are required two weeks prior to the first day of the academic school year.
- 5. Student has no current disciplinary restrictions.

# **Financial**

- 6. First tuition installment and all fee payments are required two weeks prior to the first day of the academic school year.
- 7. CFCA financial assistance is not available for any new senior students.

## **Post Enrollment Non-Negotiables:**

# \*The student will be administratively withdrawn from CFCA if he/she is described as any/all of the following:

- o If the student's GPA drops below a 2.0 at the close of the first semester
- o If the student reaches 15 demerits in the first quarter
- o If the student reaches 25 demerits at any time throughout the course of the year
- If the student's financial account is insufficient at any time throughout the course of the year
