



# **DISCOUNT OPPORTUNITIES**

## **2026-2027**

### **1.) Church Member Discount Program**

- Discount:
  - 10% off base tuition
- Eligibility: At least one parent must:
  - Be an active member in good standing at Church at the Cross (CATC) for at least 90 days prior to requesting the discount.
  - Be enrolled and actively attending an “Adult Life Group” class.
- Discounts will apply retroactively to the start of the school year.
- Families requesting this discount affirm they meet the above expectations.
- If a student withdraws or is dismissed before the end of the school year, the discount will be reversed and immediately due.

### **2.) Kingdom Family Training Discount**

- Discount:
  - \$250 per semester or \$500 annually (per enrolled student)
- To qualify, parents/guardian must attend all Kingdom Family Training opportunities within the semester.
- Kingdom Family Nights are held during the Fall and Spring semesters.
- Both parents must attend when applicable.
- Discount applied at the completion of each semester.
- Discount forfeited if student withdraws/dismissed before the end of the year.
- Families receiving scholarship monies cannot receive a discount exceeding a zero balance on accounts.

### **3.) Full Payment Discount (Non-State Scholarship Students Only):**

- Discount:
  - \$500 tuition reduction for accounts paid in full by July 1, 2026.
- Eligibility: Applies to returning students and newly enrolled students who pay in full by the deadline.
- Discount forfeited if student withdraws/dismissed before the end of the school year.
- Payment must be received by July 1, 2026 to qualify.

### **4.) Early Re-enrollment Discount:**

- During the re-enrollment season, opportunities for a re-enrollment discounts will be communicated to each qualifying family.
- Eligibility: Family tuition accounts must be current at time of re-enrollment.
- Discount forfeited if student withdraws/dismissed before the end of the school year.
- Families receiving scholarship monies cannot receive a discount exceeding a zero balance on accounts.

### **5.) Alumni Discount:**

- Discount:
  - 5% off tuition
- Eligibility: Parent/legal guardian must be a CFCA graduate with a minimum of 4 years' attendance and left in good standing.
- Discount forfeited if student withdraws/dismissed before the end of the school year.

## **6.) Student Referral Discount:**

- Discount:
  - \$250 applied to tuition for families referring to a new student who:
    - Enrolls, completes the admissions process, and remains enrolled for the academic year.
- Conditions:
  - Referred student must complete the application, take the assessment entry test, interview, grade-level review, and align with CFCA's Biblical Worldview.
  - Discount can only be made once per new student.
  - Discount may only be claimed by one CFCA family and cannot be split.

## **7.) Legacy Discount:**

- Discount:
  - \$100 per year for each consecutive year of re-enrollment, beginning in the fifth year of continuous enrollment at CFCA.
- Applies only to students in grades K5–4th when re-enrolling into 5th grade and beyond.
- Account must remain in good standing. If an account becomes 60+ days past due, the discount is revoked for the year.

## **8.) Hero Discount (Active Military/First Responders):**

- Discount:
  - 10% if a parent/legal guardian is actively serving in the military or employed as a first responder.
  - 5% if a parent/legal guardian is a retired military or first responder.
- Conditions:
  - Documented proof is required and must be updated yearly.
  - Discount forfeited if student withdraws/dismissed before year-end.
- Families receiving scholarship monies cannot receive a discount exceeding a zero balance on accounts.
- Documentation must be signed, notarized, and approved before submission.

## **9.) Pastoral Staff/Ministry Staff:**

- Discount:
  - 10% off tuition
- Parent/legal guardian must be a full-time pastor, staff, or employee of a like-minded church or para-church ministry.
- Documentation must be updated yearly and approved by CFCA administration.
- Families receiving scholarship monies cannot receive a discount exceeding a zero balance on accounts.

***All discounts will be reversed if a student withdraws or is dismissed before the end of the school year.***
